Spotlight on Resident Rights

We respect and support our residents in exercising their rights. The Department of Health Services has established a list of resident rights for assisted livings (Community Based Residential Facilities or CBRF) in the state of Wisconsin. Over the course of several newsletters I will share some of these rights with you. A full list is located in your "RESIDENT HANDBOOK".

"Right to receive prompt and adequate treatment that is appropriate to the resident's needs, within the capacity of the facility." (S.50.09(1)(1), Stats, and DHS 83.32(3)(i).

Right to receive prompt and adequate treatment can be connected to many different ways that we provide care and services, and it really comes back to person centered care. Each resident has different needs and wants as part of their Individualized Service Plan. Prompt and adequate treatment means working with a resident to help them meet their goals or remain stable, whether it is helping with care needs, observing and reporting a change in condition, or using appropriate approaches based on their diagnosis. Changes are documented and responded to in a timely

You Know Where You Want To Be! by Julie Fries, R.N.

Everyone agrees, if at all possible you want to stay in your own home for as long as possible. However, when health or safety issues arise, it may be overwhelming to cope and figure out how to manage at home, or how to get help in your home. For some people, the biggest concern may be how to pay for help in the home.

There is a common misconception that Medicare will pay for services to keep you in your home. Medicare will only pay for a limited time and only if there is a need for a skilled nurse or therapist as ordered by your doctor. Medicare does not pay for cleaning services or routine, daily personal care.



The kind of home care most seniors need to stay at home is called in-home care or nonmedical homecare. At the Valley VNA, we have a program called Options and Solutions. This program is a free, no obligation, in home evaluation. One of our Registered Nurses will meet with you to learn about your needs, answer questions, and then make suggestions and give you important information about services, programs and possible funding sources.
